With any luck the Grading List could be ready a lot earlier than last year. Some prophets even say "late August", which could wreak havok in Southview Road as the Editor tries to produce the September Bulletin a fortnight early to go with it. It will help if you get your order in in good time, but do remember the publication date is uncertain.

SCCU ANNUAL COUNCIL MEETING

The AGM was duly held on the 14th June 1980 at St Brides. The attendance was 30 (one less than last year) and every County was represented except Beds, who sent apologies, and Cambs, who didn't. The draft minutes run to four sides of A4; we hope readers will accept some degree of condensation here.

General Rules: The Special General Meeting which adopted the new Rules in January had referred to the Executive a suggestion for an additional rule enabling the Union to expel member organisations. In answer to a query the President said the Executive had deferred this matter.

Treasurer's Report: The Treasurer reported a surplus of £61. The main reasons for this satisfactory state of affairs were a substantial increase in Grading List sales, the abolition of Union grants towards the Glorney Cup, and the full-year effect of having most of our reserves in the building society.

Budget for 1980-81: After a series of amendments the Meeting finally fixed on the following: County levy £4.50 per point (up 50p); Bulletin subscription £1.50 (up 25p); Grading List £1.40 (up 15p). The reduction for bulk orders of Grading Lists remains 10p. Some feeling was expressed during the Meeting that we ought to be very careful about excessive price rises; a proposal for a County levy of £5 was roundly defeated.

County Tournaments: The Bucks delegate raised a couple of points arising from his County's AGM. (a) board order: Bucks felt sure that one County had used an incorrect order against them in a Shannon match, presumably on purpose. This is, of course, cheating. Shortage of time curtailed discussion; Mr Lauder's observation that you can't draft an enforceable rule probably came nearest the mark.

(b) Some stronger Counties, finding themselves out of the race for the Champion-ship, seemed to have given up half way through the season and stopped fielding their best teams. This, Bucks felt, had significantly affected the relegation issue. Again there was little time for discussion (though, in your Editor's view, there's really nothing to be done about this).

Minor Counties: Readers will know that Middx II had qualified for the Minor Counties semi-final. They will probably also know that Middx defaulted this match, being "unable to raise a team". Mr Thomas of Norfolk (Minor Counties runners-up in the SCCU competition) commented that his County would have liked to play in the semi-final and had been disappointed to hear of the default. (We suspect that some in Norfolk might have expressed themselves more strongly -Ed)

Mr Foley-Comer of Middx - who is not responsible for the second team, be it said - offered apologies on his County's behalf. Some discussion followed on the wisdom of holding important matches on Cup Final day. Mr Richmond wondered, and nobody seemed to know, whether the Union had a right to nominate a Minor Counties representative instead of running a competition. More than one person commented on the general lack of interest in the Minor Counties Championship. (Only four teams, out of 10 in the Montague-Jones league, entered the Minor Counties in 1979-80; and entry does not involve extra matches since MJ matches count for the Minor Counties as well.)

Grading: Mr Locke said there had been little response to his recent appeal for volunteer graders. He thought it would be necessary to offer 5p per game for the work, as some congresses were already doing. (If you can add and subtract and are short of cash, Mr Locke's address is inside the front cover.)

Junior County Matches: Mr Manning reported that these are to move to Highbury Grove School, Islington, next season. Some feared that this might disturb adult County match players if dates clashed; Mr Manning said he would check for clashes.

It was suggested that the 40-board U18 "Metropolitan" matches ought to be decided on games rather than matches, since the number of matches played was small. Mr Manning agreed that this would bear looking into, and said he would make the change at once if all four Counties agreed. He added that a game-point rule would have produced the same result as the match-point one this season, but only by a margin of half a point.

Presentation of trophies: The new Phillips and Drew Amboyna and Ebony Trophies were not yet available. The Montague-Jones Trophy had not been returned by the previous holders (surely a discourtesy? - Ed) but the Shannon and Stevenson Trophies reached their rightful destinations.

Individual Tournament Secretary's Report: Mr Manning said the play-off for the right to play in the British Championship had been won by DH Cummings who beat PG Large $1\frac{1}{2}-\frac{1}{2}$. The two share the SCCU title. There is every reason to think the Championship can be held along with the Surrey Congress again next year.

Elections: names and addresses of those elected can be found inside the front cover. Mr Lee-Pentecost volunteered at the last moment to fill the Secretarial breach for one year only. The 10 Executive Committee members were elected by ballot from 12 nominees.

Draft Tournament Rules: We shall now have to call these the "County Match Rules", which seems more sensible. Predictably, discussion tended to get bogged down and petered out half way through for lack of time. A Special General Meeting is to be arranged to complete the formalities (if that's the word). There were many small amendments to the draft, too many to detail here. We will just mention one point which seems more interesting than most:

Readers will remember that Middx won the Shannon competition from Kent in 1978-9 on game points after a tie on matches. Middx's games tally included a 20-0 win by default which boosted their score way above Kent's, and there was some suggestion at the time that this was unfair. There had been a rule, some seasons earlier, that in cases like this the defaulted match (and the corresponding one ply by the other tying team) should be discounted. For some reason this rule had got deleted from the statute, and the Executive, wishing to bring it back, had included it in the new draft before Council. It aroused probably more comment than anyone had anticipated. The Middx delegates disliked the idea of bringing back the old rule, and instanced a case in which it would be unfair: Counties A and B have tied on matches. A has scored a 20-0 default against C, and B has lost to C. Discounting the matches against C would now put B ahead on match points, and even if that was ignored and only game points counted, B would gain an unfair advantage.

A number of possible rules were proposed to replace the draft version. One was that the Executive should act as a sort of "pools panel" to decide the results of defaulted matches. (As far as your Editor could tell, this proposal was made in all seriousness.) In the end it was agreed to approve the draft version, bringing back the old rule. We could always change it later if we decided we didn't like it. (For what it's worth, the Editor's opinion is that any rule will be unsatisfactory in the nature of things. 20-0 defaults are unsatisfactory to start with and it's no use trying to make silk purses with them. For a best-of-a-bad-job arrangement you probably can't beat the old rule that's been brought back.)

Publication of Grades: The Meeting discussed a proposal to be made by the Northern Counties Union at the forthcoming BCF Council Meeting. This would require all Unions to refrain from publishing the grades of unregistered players, on pain of exclusion from BCF competitions. Messrs Poole, Croker, Locke, Richmond and Douglas had circulated in advance a paper in which they strongly opposed this proposal. The Council (SCCU Council, that is) agreed with them to the tune of 22 votes to 2 with 5 abstentions. (The arithmetic does work: one delegate had left by this time.) There was some doubt about the constitutional validity of the NCCU's proposal, and a general feeling that we shouldn't let other Unions dictate our internal affairs.

Since Editorial comment has already intruded more than once, there can't be much harm in letting it in again. On a (very) quick reading of the BCF Constitution and other rules, we can't see anything that would make the NCCU proposal unconstitutional. But we do think it silly. The Unions have their differences, heaven knows, but we must either solve them amicably or learn to live with them. There seems to be great danger of emotion taking over completely on the grading issue.

In a recent issue of the SCCU Bulletin you expressed yourself as

ignorant about the Chiltern League. Let me enlighten you.

Some five years ago the counties of Beds, Berks, Bucks, Herts and Oxon (hence the name Chiltern) whose second teams had been playing in the Amboyna and who were dissatisfied with the distances they had to travel for matches in that competition decided to opt out and form a competition of their own. Since then Beds have dropped out and Berks now enter two teams, "A" and "B", and each county plays two games, home and away, with each of the other competitors. It runs smoothly and pleasantly and

those participating are happy in it. We have preferred to remain independent of the SCCU.

The position on the left was adjudicated won for Black. White appealed, claiming a draw. A whole match, and a place in the last four of a national team competition, depended on the result.

White's extensive analysis was rejected by the adjudicator because:

1 R-Q1 N-Q2 2 Q-K2 QxP

and Black wins the King Pawn. White had failed to submit any analysis to 1... N-Q2 but, in the line given above, regarded 3 R-B7! as more than adequate. Can Black defend against Q-K6 or B-K6 or Q-N4?

White's other extensive analysis was not commented on. What do readers feel the correct result should have been?

Just for interest:

1.... B-R5 fails to 2 B-N2 etc.

1.... NxP 2 Q-K2 N-B8 3 Q-K6ch! QxQ 4 R-B8ch RxR 5 BxQch R-B2 6 RxN RxBch 7 K-R3 B-Q2 8 R-B8ch! (or 7.... R-K7 8 RxB!)

Or is 1.... N-N6 2 R-K5 good for White?

Appeals on adjudication in some areas are done on a panel basis, i.e. three adjudicators get the same position. Is this a good or bad thing? As an adjudicator for over 20 years and having been part of a panel (and also, on occasions, "the" appeal adjudicator) I would say each system is fraught with danger. There is no certificate or examination for adjudicators, and I can assure readers I know of at least one occasion when the three appeal adjudicators came to three different decisions!

I would be interested to hear from anyone who has suffered doubtful (or just plain wrong) adjudications. The most horrific example could be published in the next issue. Letters on any aspect of adjudications would be welcomed. Please send them to me care of the Editor.

LONDON PRIMARY SCHOOLS CHAMPIONSHIP 15.6.80

The top four primary schools in London met at Starcross School, Islington, to decide the Elephant Trophy, the London Primary Schools Chess Association's league Championship.

From an original entry of more than 160 schools the four qualifiers were Brooklands (NW London Champions), John Ball (SE London Champions), Newbury Park (Redbridge Champions) and Our Lady Queen of Heaven (Putney Champions).

In the Semi-final Jamboree John Ball had qualified in first place but had since been beaten 3-2 in the South of England Final by Newbury Park, the present All England Champions and London Champions three times in the last four years. So the scene was set for a very close encounter. In the first round of the APA, two very hard matches ended with John Ball beating Brooklands 8-4 and Newbury Park beating OLQH 7-5. The match between the big two took place in the second round and John Ball, with the aid of several adjudications, won 7-5. OLQH won their second round match $7\frac{1}{2}-4\frac{1}{2}$. John Ball needed a draw with the Putney school to take home the Elephant, but with sound steady play made sure of the title by winning 9-3. Newbury Park held on to second place by beating Brooklands 7-5.

Instead of the cosy all-SCCU encounter at Simpsons which had been expected (until Lancashire went and won that appeal against Kent), Middlesex had to go all the way to Birmingham for a repeat performance of last year's Final. Happily the result was also a repeat, and Middlesex are Champions for the second year running.

Lancashire fielded what was probably their strongest team and the result was in doubt until 20 minutes from the end - despite draws in 6 and 10 moves on boards 9 and 5 respectively! DN Foley-Comer, Middlesex's non-playing captain, reports that his worst moment came during the long tie-break in the Wimbledon Final, which he was watching on a portable television. Glancing over his shoulder, he was slightly perturbed to see about 10(!) of his team also watching...

Middlesex have now extended their unbeaten run to 22 matches; the last time they lost was against Kent in October 1978. The County's all-time record for consecutive wins is 26 from 1912 to 1914, and it looks as if this record could now be in danger.

BCF COUNCIL

A quick survey of the main points from the BCF Council Meeting 12th July 1980. · We have no doubt there will be a fuller report in Newsflash next month. This one is the result of a last-minute phone call to an SCCU delegate, followed by a rather hurried bit of typing to meet the deadline - so, if we've got anything wrong, at least you know why.

Congress Director voiced some doubts about BCQC representation in the British Championship. There will in future be 5 places in the Championship for people quali-fying via congresses. We have no details.

Congress Membership: Congresses can now affiliate to the BCF on payment of a fee

of 10p per game. The BCF will then be responsible for getting the games graded. It was decided after some discussion that congresses organised by Counties and other affiliated bodies would qualify for membership without payment.

The congresses will have 4 representatives on the BCF Council.

Money: It was agreed to transfer £2000 to the Levy Equalisation Fund.

Publication of Grades: The NCCU proposal (see page 2) was made in a watereddown form, as a recommendation only (and without the sanction of exclusion from BCF competitions). It thus came out as a recommendation to withold publication of unregistered adults' grades from September 1981. In this form the proposal was lost by 21 votes to 32. It was then immediately proposed, and not by an SCCU member, that all grades should be published; and this proposal was carried!!!!! (We are not sure, but we imagine this is only a recommendation. What the WECU are going to say if it isn't we daren't think. Comment springs unbidden to the Editorial fingertips but we'll suppress it, just this once, since we've had no time to think about it.)

BCF Stage County Matches: An SCCU proposal (actually made by Kent) that all

matches at this stage should be over 20 boards was lost by 16 votes to 26.

BCF Trophies: These are of considerable value and some have been vaulted away since the war. Should they be sold? Or if not, should they be fully insured? Should the active ones be presented each year, or kept in cold storage? Should some form of replica be presented? Counties' views are sought.

County Matches: Counties' views are to be sought on "eligibility for County matches", but we're not clear what this is about. The Meeting also discussed clashes

between important matches and things like Cup Finals.

Next Year's Meetings: Finance meeting 16th May (London); "Annual" meeting July in Birmingham.
