Bucks have done the unprecedented by picking up the Minor Counties title - the first first team ever to do so. They could remain the only first team to win this against second-team opposition, if anything comes of BCF proposals to put the second teams of the big boys in a competition of their own.

Surrey, of course, had already won the national Girls Ul8 title. Three championships in one year (and I hope I'm not overlooking anyone else!) doesn't seem bad going for one Union, even if it is the biggest.

#### ANNUAL COUNCIL MEETING

The Annual Council Meeting of the Union took place on Saturday 13th June 1981 at St Brides. 32 attended. All Counties except Berks were represented, though it was noticeable that only two had availed themselves of their right to produce three delegates, and some were represented only by people on the Union Executive who could have attended - and probably did - in their own right as individuals.

The (somewhat lengthhy) official minutes will of course be sent to all Counties

but the main points were:

SGM 3.10.80: This was the meeting which would, if quorate, have discussed the new Tournament Rules. Mr James (Surrey) complained that County delegates had not been told about the meeting. The President replied that all County Secretaries had been notified, and it was their job to pass the notice on. Mr James thought the position rather unsatisfactory.

Accounts for 1980-81: These showed a loss of £119, due to disappointing sales of Grading Lists and unexpected rises in general expenditure. The question of congress affiliation fees was raised; Mr Lauder thought it wrong that they should go direct to BCF because that meant the SCCU, by virtue of its greater congress activity, was irectly subsidising the other unions.

Budget for 1981-2: Mr Richmond said he had been more cautious than last year. The Meeting discussed:

 (a) <u>Bulletin subscription</u>: £2 seemed acceptable to everyone.
 (b) <u>Grading List</u>: Ordinary price £1.60; discount price (10 or more copies) £1.40; price to commercial enterprises ordering in bulk for resale £1.20. Mr Locke made it clear that all these prices were economically viable.

There was some discussion of County grading lists, largely pirated from the SCCU It was thought that these might considerably reduce SCCU sales. Mr Locke said that in spite of the copyright notice appearing on the Grading List there seemed to be a convention that Counties were entitled to produce their own lists. The point was made that the Union could now produce the Counties' lists for them if they were willing. (c) General expenditure: The Treasurer said that despite the smallness of the budgeted increase he thought he had erred, if anything, on the side of caution. The Individual Championship should in future pay for itself, and room hire and travelling expenses might be expected to come down. On the other hand it seemed that insurance costs might go up, since we had just found the Fleming Trophy to be much under-valued.

The Treasurer proposed a levy increase from £4.50 to £6. This was approved with a large majority, after an unsuccessful amendment to £6.50.

The Meeting passed a vote of thanks to the Treasurer.

Grading: Mr Locke reported on the BCF's plans for centralised grading by computer. There was much discussion, but the Meeting was hampered by the paucity of information available since the plans are still at an early stage. The system would be tied in with the BCF registration scheme, and might come into operation in 1984 (!- Ed). would render the SCCU system redundant. Much disquiet was expressed about methods of getting the game results to the computer; it seemed it would involve some people in very tedious operations. The local grader would become extinct.

Mr Locke reminded the Meeting that as from 30th April 1981 the Union was no longer accepting results for grading from unaffiliated congresses (with the exception of County ones). The question of league affiliation was to come up at BCF level.

County competitions: There were so far only three entries for the Ebony Shield next year (two from Surrey and one from Kent). It was hoped Essex might enter.

MrWR Bonds of Kent was reappointed Auditor.

Inter-County Competitions: The Executive had come up with some ideas for reducing travel expense and fixture congestion. Eventually no decisions were made, but the ideas remain on the table if anyone wants to take them up again. The suggestions were:

(a) the top 2 divisions to be reduced to 8 teams each. Surrey were happy with this; Beds and Bucks said no. (b) an extra division for the teams displaced from the top 2. Obviously this depended on reaction to (a), and nobody could see where the teams were going to come from to make up the numbers into a sensible competition. (c) Regionalisation, and sub-division of Counties, in the lower divisions. There was mixed reaction to this. (d) Promotion and relegation throughout. Mixed reaction again.

(e) A reduction in the size of teams (16 being the minimum BCF requirement). The idea was scarcely more than touched on.

One member said he would like to see 1st and 2nd team matches played simultaneously. This would make things easier for clubs that played their matches at weekends. The arrangement permitting Cambs to play all their matches in the university term was also

brought up, as it had been at at least one recent AGM.

Tournament Rules: The Meeting now undertook the job of finishing off the draft Tournament Rules. Your Editor must confess that after more than 12 months of this he is starting to find the whole thing a little tedious, so briefly: The remainder of the draft from Rule 10 was considered and accepted, with one significant change: The number of nominations now required for the first team is 18, not 20 as proposed. It remains 14 for other teams.

The nomination rule provoked some discussion, of course. It was actually suggested that all nominated players should be required to play. Another suggestion, perhaps more practicable, was that the top 14 boards in a first team's first match of the season should automatically become "nominated".

The other bit of the eligibility system, preventing a player from going down a team after three appearances, also roused comment. Some felt it was too easy for a player to represent two or three teams regularly in spite of this rule. But of this more on a later page.

The Executive was asked to consider alternatives to both aspects of the eligibility rules. In the meantime, however, the draft rules (as amended) are in force.

## LETTER

Dear Mr Haddrell,

Team "overlap": Your paragraph on this subject, while recording (?regretfully) that no rules were broken\*, seems to favour keeping a County's teams "distinct". Aren't you being ivory-towerish?

It has to be recognised that no team is likely to go through a season unchanged; a player may be sick, or prevented by personal or business reasons from playing. So reserves are necessary. Even the model County cited in your paragraph needed 27 reserves for two teams. The problem is to treat the reserves fairly.

What can a "distinct" County with four teams do? It can (a) allot the best 80 players to the four teams, and give the first vacancy which occurs in the first team to the 81st; who would that please? Not the I team captain, not the opponent who expected a good game, not players at the top of the II team who can reasonably expect a chance

to show that they are worthy of higher things. Or it can (b) allot the best 20 players to the I team, keep nos. 21 to 25 as I team reserves, allot nos. 26-45 to the II team with nos. 46-50 as reserves for the II team and so on.

The reserves for each team, debarred from playing for their proper team, but getting only occasional games when a vacancy occurs, would certainly feel frustrated as compared with their colleagues a few places further down in the County order; these colleagues would get regular games with the dates known well in advance, and not a late call because someone has dropped out.

The present compromise system of a limited number of nominated players plus the grading limitations is reasonable and workable. Please don't make the captain's life more difficult than it presently is by pursuing this concept of "distinctness".

Ed: I'm sure you must have expected my comments, Mr Green, so I won't disappoint you. I am in the happy position of agreeing with almost every word you say (except about me being ivory-towerish). You have convincingly demolished a position I have never defended and do not hold.

I agree that the present system is basically reasonable. Of course the first-team reserves must come from the second team, and so on. But I think the system needs considerable refinement, because it is very lax and - what is worse - is being interpreted differently in different Counties.

I would think it reasonable for any second-team player to have two or three outings in the first team. Not more than three, I don't think; it shouldn't be too hard for the first-team captain to satisfy his requirements by using reserves up to three times each. I expect that was in the mind of whoever drafted the current rule: the one which says you can't play in a lower team after three appearances in a higher the trouble lies in that word "after". If you choose your dates right it is quite possible to play half a dozen times each for two different teams, or regularly for three different teams. The result is that some players - not very many - are "full" members of more than one team, and I think this tends to destroy the concept of lst, 2nd, 3rd teams.

I would like to quote an example from last season. This one is rather extreme, though I could have chosen similar examples from clsewhere. A certain player turned out 13 times in the course of the season, for the first, second and third teams in this order, or something very like it: 2,3,2,3,3,2,1,1,2,2,1,2,1. Now I don't think that's right. An improving player who worked his way up towards the first team as the season progressed? I don't think so; he played on a highish board in the second team in the previous season. If my (rather vague) memory serves me right, the magic figure last year was four (appearances in a higher team...). This means he didn't break any rules. Even under the present rules with the magic number three, only one of his appearances would have been illegal.

There is a small band of players like this, freelancers who will apparently turn out for whichever team has a match on on the day. I respect their keenness but would suggest that it is out of place in these competitions.

My remedy? A rule saying "No player may in the course of a season make more than three appearances outside the team he plays for most often." (That wants refinements to the drafting, but it's what I mean.) When I suggested it at the AGM people seemed to think you'd need a crystal ball half way through the season in order to apply it, but that's not so.

There I go again, writing comments longer than the letters they go with... Of course you can reply, Mr Green.

HOME OR AWAY? A postscript to an item in "Round the Counties" last time. We reported that Zenith Chess Club (Maidstone Prison) had failed to get into the Kent club competitions because of their awkward hours and the complete ban on visiting U18s. We asked if anyone knew of a prison team actually competing in a league. Well, there is at least one. Paul Buswell tells us of a prison team named Appleton which is a member of the Warrington and District League. They played in division 5 (of 6) in 1979-80, finishing near the bottom. Only 2 hours is allowed for play, but 12-17 year olds can visit with parental consent. We don't know why the difference in regulations on juniors; with 12 year olds allowed Zenith CC might well have got in.

We hear from the same source that Lowestoft CC have a slight problem: the owners of their premises (a yacht club) are now insisting on jacket and tie for all players, visitors included. Chess players' sartorial habits being what they are, this could prove unpopular.

SCCU JUNIOR ORGANISER: You will have noted, if you read the AGM report on page 1, that this post was left temporarily vacant. No candidate has yet emerged, and in the interim Fred Manning is continuing to shoulder the burden. This is hardly fair to Fred who has a hundred and one other jobs. Any volunteers? The job involves co-ordinating the Counties, being present (whenever possible) at SCCU junior matches - about 5 Saturdays a year, unless we've missed any - and liaising, occasionally, with outside bodies such as the BCF. The BCF Junior Squad/SCCU Junior Championships are not involved. Serious volunteers for office could contact the SCCU President, Jeff Douglas, whose address appears inside the front cover; or, for that matter, Fred Manning himself.

It looks at the moment as though Berks' attempt to get into the "Metropolitan" 40-board league will founder upon the rocks of fixture congestion. This seems a great

## REVIEW

Janos Flesch (translated by John Reti): Batsford 150pp THE MORRA (SMITH) GAMBIT £6.95 paper covers. Figurine algebraic.

In 1964 I played chess in Cracow, Poland. One of the most impressive things in otherwise drab surroundings were the bookshops and the cheapness of the books, many of which were technological. As with most Russian and Polish books of the time the quality of the paper was notably second rate. It is extremely sad to say that this book on the Morra (Smith) Gambit reminded me immediately of that Russian and Polish paper some of which is now yellow with age.

The second unfortunate detraction I suffered before digesting the content of the book occurs on the front cover where it says "1 e4 c5 2 d4 cd 3 c3" but where the chess board set up is 1 e4 c5 2 c3! Not very impressive as this should be the cover for "2 c3 Sicilian" by MG Chandler and, would you believe, a Batsford chess book.

The next sadness I have is alleded to on the back cover where it says "The opening is known in the US as the Smith-Morra Gambit in recognition of the contribution by the Texan master Ken Smith, who popularised this variation." Is this an olive branch in apology for what occurs between the covers? To quote, "According to K Smith white stands better. This however is not always the case." Or, "We can see that the K Smith type of deduction is wrong for the variation leads to a loss not a win." Or, "K Smith gives this move an exclamation mark. Admittedly there too the combination is analysed faultily." It seems rather a pathetic feud but perhaps ultra-keen competition might produce fine analysis. But does it?

Frankly the book contains many fine games which are grouped together under lines of analysis rather than move by move analysis of alternatives. The chapter breakdown is

well thought out and gives considerable attention to the Bc4 lines of the Gambit Accepted but the treatment of the Morra Gambit Declined is sadly perfunctory.

There are also a number of text errors in the book, e.g. on page 1: "1 e4 c5 2 Nf3 d6 3 d4 cd 4 d3" - which is impossible of course. An occasional diagram has a drunk pawn which is not standing straight on the board.

Despite these extremely annoying quality and vendetta problems this is the most authoritative Morra Gambit exposition available and should sell well to the dedicated gambit player.

ANALYSING THE ENDGAME
Jonathan Speelman: Batsford 144 pp £4.95 paper covers.
Figurine algebraic.

To start with the criticisms: I agree with my colleague in the previous review that Batsfords don't use very nice paper, though the book is otherwise nicely produced. The spelling mistakes (preceded, seperated -twice-, tieing, infinitessimal) are horrible, there are some misprints in the moves which can make a variation unintelligible, and at least two diagrams are wrong; one seemingly one-sided ending took on new meaning when the two missing pawns suddenly materialised in an intermediate diagram. Mr Speelman writes well and one must assume that he is not responsible for these blemishes. Mishaps are no doubt inevitable in a book of this nature, but the ones I have noted suggest corner-cutting unworthy of a major chess publisher.

A side-issue? Maybe, but it had to be said. Now down to the book. The first half consists of corrections and reassessments of endgame analysis published elsewhere; the venerable Basic Chess Endings features very largely, though attention has been given to much more recent works by Averbakh, Levenfish, and Keres. Chapters are dvoted to Pawns, Rooks, Bishops of opposite colour, Minor pieces, Queen and centre pawn v Queen, and Pieces v pawns. This is not an endgame manual and some of these chapters revolve more or less around a single position, with variants. But a lot of it goes into considerate depth and makes fascinating reading.

The second half of the book looks at actual game endings. First an in-depth analysis of that famous Spassky-Fischer ending (Reykjavik 1972, game 1/2), in which Fischer went ... Bxh2. Speelman must have devoted very many hours to this, and justifies the depth of his analysis by suggesting that it demonstrates the limits beyond which judgment must take over. ("Because it was fun" might have been an even better justification - but then I didn't do it.) The book concludes with some "practical endings" from Speelman's own play and from Miles's games at the Riga Interzonal, where Speelman was his second.

The book is a nice blend of the practical and the unpractical, the important and the not-so-important. I have enjoyed playing through the endings - selectively, for there are far more hours' reading in it than I have been able to find. I have not discovered any flaws in the analysis, but with my grade I wasn't expecting to. I expect there are some; Speelman has shown that you can't write this sort of book without making mistakes. He has drawn on - as well as occasionally demolishing - the work of numerous analysts and there are full acknowledgments in the text. (One puzzle, though: the "short bibliography" of works on the Fischer-Spassky match, prominently referred to at both ends of the book, ends with the words "Here is a list of some other books on the match:" - and there follows one (Batsford) title. I can't make up my mind whether this is a printer's error or an obscure joke.)

With the reservations expressed in the first paragraph, I recommend this book.

TRAIN LIKE A GRANDMASTER Alexander Kotov: Batsford 124pp £4.95 paper covers. Figurine algebraic. Translated by Bernard Cafferty.

A follow-up to the earlier Batsford titles "Think like a Grandmaster" (1971) and "Play like a Grandmaster" (1978). Both estimable works indeed. But this one? A charitable person would say "de mortuis" and talk of something else, but as I'm a reviewer:

The second half of the book, and far the more interesting, pictures the Soviet system of chess training - a monumental undertaking by the sound of it, revolving around the chess sections of Pioneer Palaces but featuring also year-round television courses for different categories. The pages on the historical development of the system make interesting, if brief, reading. And one myth dispelled: chess isn't on the school curriculum in the USSR. I daresay none of this is any secret, but a lot of it was news to me.

The other worthwhile feature of the book, to my mind, is the games; largely by prominent members of the various regional schools and well worth playing through. And I nearly forgot to mention the in-depth analysis of critical positions quoted to illustrate postal contributions that flood in from nobodies in the backwoods.

A large part of the book, however, is taken up with Kotov's strictures on modern chess (what has happened to the creative element?) in which he frankly says nothing new and says it at considerable length. Longish tracts on methods of analysis and preparation, and a historical survey of chess thought, seem to me like so much space-filling; as do the bits about relationships between trainer and trained. The style of the book I found jarringly "loyal" and sloganful.

University of Kent at Canterbury is laying on a course 28-31 August for beginners and novices. Meals provided, £45 residents £35 non-residents. Contact Bulletin for details

# BCF COUNCIL MEETING 11.7.81

A quick report. Details came by telephone from two delegates who seemed pretty well in agreement, so we hope we've got it more or less right. There will no doubt be a fuller report in the August Newsflash. We have tried to miss out the boring bits.

Accounts were circulated at the Meeting. The Auditor was critical of the Phillips and Drew accounting procedures. (We hasten to add that we're talking about the chess event. We have no reason whatever to suppose that Phillips and Drew did the accounts!)

Team competitions: It was agreed by 21 votes to 19 to have a second team competition (which in effect, of course, we already have). An upper grading limit of 175 was backed by some smaller Counties, but 200 eventually agreed 22-16. It was also agreed 22-16 that 1st and 2nd team matches in the BCF stage should take place simultaneously.

Council agreed (we think) to have a Minor Counties competition fitting its name. There was some discussion on the definition of a Minor County; levy limits were talked of, as well as a provision to admit all Counties who had not reached the BCF stage in the previous 5 years. Both schemes have snags (Cambs, for example, are stronger than their levy number suggests). No final decision was taken, and we do not know when the Minor Counties competition is expected to get off the ground.

The decisions on team competitions are, we understand, advisory. PM Shaw was not

happy about some of them.

Centralised grading: Some spoke against this, on the ground that it would leave no place for the volunteer grader. Council agreed, however, that the Federation should continue its planning. (This means, we imagine, that the plan will eventually come into effect provided there are no unexpected developments.)

The interim grading list is not selling well.

Publicity Director: This office was left vacant; the Management Board may co-opt.

British Championship is to be open to non-British-Citizens of 5 years residence.

Board fees: A strong move to abolish these failed in the face of Management Board opposition. The travel grant for the BCF-stage was, however, abolished. (This was vattable, it appears.)

Congress affiliation: "County" congresses not affiliating in the normal way will in future qualify for grading only if 100% registration is required. This does not apply to congresses with an upper grading limit of 125 or less, or to junior events.

Future BCF Congresses: 1982 Twickenham (this is more or less final); 1983 South-

port; 1984 Brighton.

Next year's meetings: Finance: 15 May at Birmingham. AGM: 17 July in London. (We gather this one is subject to clashes with a football competition in Spain, but find it hard to believe.)

A Minor Riot appears to have occurred at one stage on some inferior story of the hotel. This had no effect on Council's deliberations.

## GAMES OR MATCHES?

There has been sporadic comment in recent Bulletins, mostly from the Editor, to the effect that leagues ought to be decided on game points rather than matches. The June issue of the Norfolk CCA News Bulletin contains an impassioned plea for the County's leagues to change from games to matches... The Kent Schools League recently changed (guess why) in the other direction and the schools have approved the game-point system in the proportion of about 2 to 1. Any views? (The London Schools League used to work on games only, but now lets both teams through if a different team gets most match points.)

On a totally different aspect of scoring, Paul Buswell asks: "Has anyone experimented with scores of - - rather than 1 - 1 in quickplay finishes?" The Bulletin would vigorously oppose this on the ground that its typewriter hasn't got the requisite fractions.
